

## The Friends of Green Chimneys Summer Camp 2025 Scholarship Application

The Friends of Green Chimneys seeks grants from foundations and supporters so that we can offer scholarships to families that otherwise would not be able to send their child to camp. Scholarships are awarded based on need and the availability of funds. The Scholarship Committee will begin to review **completed applications** in order of receipt and applicants will be contacted on a rolling basis. **Funds are limited.**

Scholarships will be awarded on an individual basis and parents/guardians will be responsible for any additional tuition not covered by the scholarship.

### **Instructions: (please read carefully to make sure your application can be processed)**

- 1. Please complete a 2025 Summer Camp Registration online by going to [www.greenchimneys.org/camps/](http://www.greenchimneys.org/camps/) and pay the minimum deposit.** Your deposit will be refunded if a scholarship is not awarded and you can't afford camp. You may call AJ Johnson at 845-225-8226 x1600 to arrange a payment plan for the deposit. ***Please be sure to register before submitting your scholarship application. Your application cannot be processed unless you have registered your camper(s) for camp.***
2. Complete the scholarship application form.
3. Include a full copy of your **2024 W2 Form and any additional documentation (child support documentation, food stamp, court orders etc)** as income verification with this application.
4. **Submit your completed 2024 Income Tax Form 1040 as soon as you have them completed. The Scholarship Committee will not finalize any applications without these forms**
